#### **Official Sweepstakes Rules**

(Last Updated March 19, 2010)

#### **1. Sweepstakes Overview, Area & Term.**

**NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Welcome to the 2010 Purina Wildlife Series Sweepstakes (“Sweepstakes”), sponsored by Land O’Lakes Purina Feed LLC (“Sponsor”), offering to eligible Participants the chance to win the Grand Prize: One (1) Bad Boy® Buggies XT Stretch Model All Electric 4WD, worth an approximate retail value (“ARV”) of \$20,000, or the First Prize: Five (5) tons of Purina AntlerMax® Deer Feed, worth an ARV of \$2,400, as more fully described and subject to the terms and conditions specified in these Official Sweepstakes Rules. The Sweepstakes entry period commences on March 1, 2010 (12:00:01 a.m. CST) and continues through and including December 31, 2010 (11:59:59 p.m. CST) (“Sweepstakes Term”). This Sweepstakes includes the United States and the District of Columbia but is void in the State of New York.

Participation in the Sweepstakes is only available to individual legal residents of the United States, except for residents of the State of New York, who are at least eighteen (18) years of age at the time of the entry (together with all other eligibility and participation criteria as specified herein, a “Participant”). Employees, contingent staff persons, officers, and directors of Sponsor and its subsidiaries and affiliates, together with members of their immediate families (parent, child, sibling, and spouse of each), and those living in their same households (whether or not related), are ineligible to enter and participate in the Sweepstakes. The Sweepstakes is void where prohibited or to the extent restricted by law.

These specifications, terms, and conditions relating to the Sweepstakes comprise these Official Sweepstakes Rules (“Rules”), and shall govern and apply to all participation and activity arising out of and relating to the Sweepstakes. Interface with Sponsor through its Sweepstakes-related web properties shall additionally be governed by the prevailing and posted Privacy Statement, Terms of Use, and other disclosed terms and conditions. In the event of a conflict between the Rules and any other official Sweepstakes-related communications by Sponsor, these Rules shall govern. Participant shall review these Rules which, by Participant’s participation and as a condition to claiming, redeeming, and use of any Sweepstakes prize, Participant agrees will govern all aspects of Participant’s relationship with the Sweepstakes and Sponsor. ## **2. How to Enter.**

No purchase necessary to participate in the Sweepstakes. To enter, Participants must complete an Official Purina Wildlife Series Sweepstakes Entry Form at any of the Purina Wildlife Series Events listed on [www.AntlerMax.com](http://www.AntlerMax.com). Limit one (1) entry per person. All entries must be received by no later than 11:59:59 p.m. CST on December 31, 2010 to be eligible to win.

Participants may request an Official Purina Wildlife Series Sweepstakes Entry Form by mail by sending a self-addressed, stamped envelope to: Purina Wildlife Series Sweepstakes Entry Form, P.O. Box 511280, St. Louis, MO 63151-1280. Requests for Official Entry Forms must be postmarked by January 3, 2011 and received by January 10, 2011. VT residents may omit return postage. Limit one (1) entry form request per person.

Limit one (1) entry per name/address/e-mail address regardless of the method of entry. The Sponsor is the official time keeper for this Sweepstakes. Proof of e-mailing does not constitute proof of delivery or entry. Any attempt to submit more than the maximum number of entries using multiple/different identities or any other methods may void that Participant's entry. No other forms of entry are valid other than those set forth above. All entry information becomes the property of the Sponsor and will not be returned.

## **3. Prizes.**

**One (1) Grand Prize:** One (1) Participant ("Grand Prize Winner") will receive One (1) Bad Boy® Buggies XT Stretch Model All Electric 4WD. ARV of Grand Prize is \$20,000.

**One (1) First Prize:** One (1) Participant ("First Prize Winner") will receive Five (5) tons of Purina AntlerMax® Deer Feed. ARV of First Prize is \$2,400.

There are a total of two (2) Prizes with an overall ARV of \$22,400. Odds of winning any Prize depends upon the total number of eligible entries received. Limit one (1) Prize per person.

Winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Term. Drawings will be conducted on or about January 14, 2011 by an independent judging agency whose decisions are final and binding in all matters relating to the Sweepstakes drawing. Each Participant selected (each a "Winner" and collectively "Winners") must comply with all terms and conditions of these Rules. Winners will be notified by e-mail,

telephone, or mail on or about January 21, 2011. Winners must properly complete, sign, notarize, and return to Sponsor by mail within ten (10) days of being notified, an Affidavit of Eligibility and Liability/Publicity release in order to confirm eligibility for Prize (unless prohibited by law). If a Winner cannot be contacted after the first attempt; if Winner fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period; or, if Winner is otherwise ineligible pursuant to these Rules; the Winner will be deemed to have forfeited the Prize. In the event of forfeiture by a Winner, an alternate Winner will be selected from among the entrants received during the Sweepstakes Term at random.
